- Reviewed campaign status report, on pace with fundraising same time last year
- Tocqueville co-chair John Cooper is reviewing lapsed Tocqueville donor list and reconnecting
- Lots of new residential gifts
- Solicitation to be sent in early February 2019
- Annual Campaign Cabinet meeting scheduled for February 6th at GUW office

COMMUNITY IMPACT – William Finger, Vice Chair

Grants Committee - Kathleen Burgweger, Chair

- 2 meetings held in January 2019 to review CIP volunteer recommendations
- \$851,000 total grant awards, decreased from last year → 20 applicants this cycle vs. 18 applicants last year
- Disappointed with submitted grant application and grant reports, many were incomplete and/or late
- GUW as grantor has a responsibility to ensure grant dollars spent as indicated and in the best possible manner
- ½ grant award to be sent in February 2019 and ½ in June 2019
- Accepting 2nd round of grant applications in May 2019
- GUW to better educate and revamp process → David Rabin to meet with CEOs and Directors of Development from each organization between February – March 2019
- David will convey disappointment in current submissions and final reports → stronger criteria will be outlined
- David will review errors and provide constructive feedback regarding grant applications and final reports.
- Robert Moore, Director of Community Impact, is developing a Community Investment Process Task Force (CIPTF) to revamp grant process
- While the need for funding programs and services is understood, the organizations must be accountable to GUW when reporting on grant award spending.
- Bazini Hopp will issue press release for Grants Recipient Reception at Greenwich Hospital on Feb 13th
- New organizations are eligible for the 2nd round of grant applications

FINANCE COMMITTEE – Eileen Kim, Vice Chair

Board Designated Reserve Fund (BDRF) Committee – Mario Forlini, Chair

- Conference call held on January 14th with Brown Advisory for annual review of allocations
- Mario reviewed details of the report investments trimmed on quarterly/seasonal basis to account for market fluctuations
- Discussion: current GUW lease is approximately \$600 per month (utilities only), rent will increase after July 2019 to approximately \$80K per year
- Motion to approve the BDRF total return recommendation by Mario Forlini:
 I move that the Greenwich United Way Board of Directors approve the Board Designated Reserve Fund Committee total return recommendation for the appropriation of \$82,250.

 These funds will be distributed to the working capital account in accordance with the GUW Investment Policy Statement approved by the Greenwich United Way Board of Directors, October 18, 2017.

2nd by William Finger. The motion passed unanimously.

Finance Committee – Eileen Kim, Vice Chair

- Thanks to all Board members who attended conference calls to review the 2018/19 final budget
- Brief discussion ensued
- Motion to approve the final budget made by Eileen Kim:

I move that the Greenwich United Way Board of Directors approve the 2018/2019 final budget as posted on the portal and sent to all Board members in advance of this meeting. This budget includes grants in the amount of \$581,500 as presented in the Grants Committee report as posted on the portal and sent to all Board members in advance of this meeting. All Greenwich United Way funding commitments are conditional based on the success of GUW's fundraising efforts as well as each agency's adherence to both the Funding and Publicity Agreements.

2nd by Mario Forlini. The motion passed unanimously.

NO New Business.

Anne Sherrerd asked for a motion to adjourn. William Finger made the motion and 2nd by Joui Hessel. The motion passed unanimously.
